ORDINANCE NO. 22-001 HOMER TOWN COUNCIL DISTRICTS (2022)

AN ORDINANCE ESTABLISHING BOARD OF SELECTMEN DISTRICTS IN AND FOR THE TOWN OF HOMER, LOUISIANA

BE IT ORDAINED by the Homer Board of Selectmen of the Parish of Claiborne in regular session, duly convened, in keeping with the authority granted by applicable federal and state laws and regulations, and in order to effect reapportionment of its voting districts following the 2020 United States Decennial Census in accordance with the Louisiana State Revised Statute 18.1922, the boundaries of the Homer Board of Selectmen districts are hereby redistricted so as to provide for population equality among the districts as near as reasonably practicable by the adoption and ratification of the document attached hereto and made a part of hereof.

<u>SECTION 1</u>: The boundaries of each of the Town of Homer, Louisiana Board of Selectmen Districts are hereby established utilizing Town of Homer corporate limits, visible features, and extensions of visible features, all of which are recognized by the U.S. Census Bureau, as follows:

DISTRICT 1

Beginning at the intersection of Louisiana Highway 146 (Beardsley Avenue) and the southern corporate limits of the Town of Homer, thence proceed northerly then northwesterly on Beardsley Avenue to its intersection with East 5th Street, thence proceed southerly on East 5th Street to the its intersection with South 4th Street, thence proceed westerly on South 4th Street to its intersection with Owens Street, thence proceed northerly on Owens Street to its intersection with East 3rd

Street, thence proceed westerly on East 3rd Street to its intersection with East Main Street, thence proceed southerly on East Main Street to its intersection with South 6th Street, thence proceed westerly on South 6th Street to its intersection with U.S. Highway 79, thence proceed first westerly then southwesterly on U.S. Highway 79 (also Minden Highway) to its intersection with Pearl Street, thence proceed westerly on Pearl Street to its intersection with Memphis Street, thence proceed southerly on Memphis Street to its intersection with Arthur Street, thence proceed westerly on Arthur Street to its intersection with the western corporate limits of the Town of Homer, thence proceed first southerly, then westerly, northerly, southeasterly, southerly, easterly, northerly, easterly, southerly, easterly, southerly, easterly, northerly, easterly, southerly, easterly, southerly, easterly, northerly, easterly, northerly, easterly, northerly, easterly, northerly, easterly, northerly, easterly, northerly, easterly, along Parish Road 23, southerly, easterly, northerly, then easterly along the corporate limits of the Town of Homer to its intersection with Louisiana Highway 146 (Beardsley Avenue), the point of beginning.

DISTRICT 2

Beginning at the intersection of Washington Street and Pearl Street, thence proceed northeasterly then northerly on Washington Street to its intersection with South 4th Street, thence proceed northeasterly on South 4th Street to its intersection with West 4th Street, thence proceed northerly on West 4th Street to its intersection with North Main Street, thence proceed westerly on North Main Street to its intersection with West 6th Street, thence proceed southerly on West 6th Street to its intersection Dutchtown Road, thence proceed westerly, then southwesterly on Dutchtown Road to its intersection with Lewis Street, thence proceed southerly on Lewis Street to its intersection Monroe Avenue, thence proceed westerly on Monroe Avenue to its intersection with Dutchtown Road, thence proceed northeasterly on Dutchtown Road to its intersection with western corporate limits of the Town of Homer, thence proceed first northwesterly, then southwesterly, southeasterly on the corporate limits of the Town of Homer to the intersection of Dutchtown Road and Pearl Street, thence proceed southerly on Buckner Street to its intersection with Arthur Street, thence proceed easterly on Arthur Street to its intersection with Memphis Street, thence proceed northerly on Arthur Street to its intersection with Memphis proceed easterly on Pearl Street to its intersection with Washington Street, the point of beginning.

DISTRICT 3

Beginning at the intersection of the western corporate limits of the Town of Homer and its intersection with Dutchtown Road, thence proceed easterly on Dutchtown Road to its intersection with West 6th Street, thence proceed northerly on West 6th Street to its intersection with North Main Street, thence proceed easterly on North Main Street to its intersection with West 3rd Street, thence proceed northerly on West 3rd Street to its intersection with Old Cemetery Street, thence proceed westerly then northerly on Old Cemetery Street to its intersection with Edgewood Drive, thence proceed northwesterly on Edgewood Drive to its intersection with Johnson Road, thence proceed northwesterly on Johnson Road (also Louisiana State Highway 540) to its intersection with the corporate limits of the Town of Homer, thence proceed first westerly, then southerly, westerly, southerly, easterly, southerly, westerly, southerly, easterly on the corporate limits of the Town of Homer to the intersection with Dutchtown Road, the point of beginning.

DISTRICT 4

Beginning at the intersection of Washington Street and Pearl Street, thence proceed easterly on Pearl Street to its intersection with Minden Highway, thence proceed northeasterly on Minden Highway to U.S. Highway 79 to its intersection with South 6th Street, thence proceed easterly on South 6th Street to its intersection with East Main Street, thence proceed northerly on East Main Street to its intersection with Beardsley Avenue, thence proceed easterly then northeasterly on Beardsley Avenue to its intersection with Louisiana State Highway 146, thence proceed northwesterly on Louisiana State Highway 146 to its intersection with East 3rd Street, thence proceed northeasterly then northerly on East 3rd Street to its intersection with the Louisiana and Northwest Railroad, thence proceed northeasterly, northerly, then northwesterly to the corporate limits of the Town of Homer, then proceed westerly, then northerly crossing over Louisiana State Highway 2, then westerly, northeasterly, northwesterly, northwesterly, northwesterly, southwesterly, southerly, southwesterly, southwesterly, southeasterly, northeasterly, northeasterly, northwesterly, northwesterly, northwesterly, northwesterly, northwesterly, southeasterly, northwesterly, northw corporate limits of the Town of Homer to Louisiana State Highway 2, thence proceed easterly on Louisiana State Highway 2, then first southerly then westerly along the corporate limits of the Town of Homer to its intersection with Louisiana State Highway 540 (Johnson Road), thence proceed southeasterly on Johnson Road to its intersection with Edgewood Drive, thence proceed southeasterly, then easterly on Edgewood Drive to its intersection with Old Cemetery Road, thence proceed southerly then easterly on Old Cemetery Street to its intersection with West 3rd Street, thence proceed southerly on West 3rd Street to its intersection with North Main Street, thence proceed southerly on North Main Street to its intersection with West 4th Street, thence proceed southerly on West 4th Street to its intersection with South 4th Street, thence proceed southerly then southwesterly on Street to its intersection with Washington Street, thence proceed southerly then southwesterly on Washington Street to its intersection with Pearl Street, the point of beginning.

DISTRICT 5

Beginning at the intersection of the northern corporate limits of the Town of Homer and the Louisiana and Northwest Railroad, thence proceed southeasterly on the Louisiana and Northwest Railroad to its intersection with a branch located approximately 1,000 feet from the corporate limits of the Town of Homer, measured along the Louisiana and Northwest Railroad, to its intersection with North 4th Street, thence proceed easterly on North 4th Street to its intersection with East 4th Street, thence proceed southwesterly on East 4th Street to its intersection with North 3rd Street, thence proceed westerly on North 3rd Street, then southwesterly along the Louisiana and Northwest Railroad to its intersection with East 3rd Street, thence proceed southerly on East 3rd Street to its intersection with Louisiana Highway 146 (which is also Beardsley Avenue), thence proceed easterly on Beardsley Avenue to its intersection with Owens Street, thence proceed southerly on Owens Street to its intersection with South 4th Street, thence proceed easterly on South 4th Street to its intersection with East 5th Street, thence proceed northerly on East 5th Street to its intersection with Beardsley Avenue, thence proceed southeasterly then southerly on Beardsley Avenue to its intersection with the southern corporate limits of the Town of Homer, thence proceed first easterly, then northerly, northwesterly, northeasterly, northerly, westerly, northerly, westerly, southerly, easterly, southerly, southeasterly, southerly, then westerly on the corporate limits of the Town of Homer to its intersection with the Louisiana and Northwest Railroad, the point of beginning. **BE IT FURTHER ORDAINED** that the Selectmen district boundaries as redistricted shall become effective with the opening of the qualifying period for the primary election for members of the Homer Board of Selectmen in 2022 and for all purposes upon the assumption of office by the members of the Homer Board of Selectmen in the year 2023. The Homer Town Board shall be divided into the Selectmen Districts provided in this Ordinance for the purposes of election of members at the regular elections.

SECTION 2: A copy of this ordinance shall be published in one issue of the official journal of the Town of Homer, as required by law.

SECTION 3: All Ordinances or Resolutions that are in conflict with this Ordinance are hereby expressly repealed. If any part of this ordinance is declared unconstitutional, then the balance of said ordinance shall be valid.

The above and foregoing Ordinance having been submitted has been read in full, section by section, and was thereupon submitted to a vote, the vote thereon was as follows:
