Residents can contact City Hall to see if Town bins are full before dropping items off.

Councilwoman Joyce Ivory recommended that a notice be posted in the newspaper or on the monthly water bill notifying customers that Republic Services will not pick up items placed on the curb such as furniture.

Mr. Hand stated that he is highly concerned about the amount of legacy liabilities and encouraged the Council to monitor the budget.

ENTER INTO A COOPERATIVE ENDEAVOR AGREEMENT WITH THE E911
CLAIBORNE PARISH COMMUNICATIONS DISTRICT**

WHEREAS, the E911 Claiborne Parish Communications District has insufficient funding to provide 911 emergency services; and

WHEREAS, 911 emergency services are currently provided for the Town of Homer and these services are critical for the town; and

WHEREAS, the E 911 Claiborne Parish Communication District has submitted a cooperative endeavor agreement to the Town of Homer proposing that the Town of Homer contribute \$10,000 per year for 3 years to defray the cost of 911 emergency services.

THEREFORE, the Board of Selectmen hereby authorize Mayor Xanthe Seals to enter into a Cooperative Endeavor Agreement (Copy Attached) with the E911 Claiborne Parish Communication District.

COOPERATIVE ENDEAVOR AGREEMENT

THIS COOPERATIVE ENDEAVOR AGREEMENT (the "Agreement") is effective on the 1st day of September 2025, (the "Effective Date") by and between E911 Claiborne Parish Communications District (hereinafter referred to as "Grantor") and the Town of Homer, Inc. (hereinafter referred to as "Grantee"), both of which are duly formed Louisiana governmental entities that are authorized to and are doing business in Claiborne Parish, Louisiana.

RECITALS

WHEREAS Grantor provides 911 emergency services for the citizens of Claiborne Parish.

WHEREAS Grantor has insufficient funding to continue to provide such services to the citizens of Claiborne Parish without additional funding contributions from Grantee.

WHEREAS Grantee is willing and desires to help fund, in part, Grantor's operations as described above;

NOW THEREFORE, in consideration of the premises and mutual promises and covenants contained in this Agreement, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged and agreed, the Parties agree as follows:

Grantee enters into this Cooperative Endeavor Agreement with Grantor, wherein Grantor continues to provide 911 emergency services, and Grantee agrees to contribute \$10,000 per year to Grantor to help defray the costs of Grantor's services, for a period of three (3) years from the effective date of this Agreement.

Grantee further agrees to make this annual payment by the 5th of September of each year, with the first payment to be made by September 5, 2025.

Either party hereto retains the right to terminate this Agreement, with or without cause, so long as written notice is sent to the other party's chairperson greater than 90 days prior to any subsequent anniversary date of this agreement.

Grantor further agrees to aggressively pursue increasing all revenue options available to it so that the costs associated with this Agreement may be decreased or discontinued altogether.

By execution of this Agreement, each party hereto executing this Agreement represents and warrants as follows:

i. This Agreement has been duly authorized, executed and delivered by the executing party and represents a legal, valid and binding agreement of that party and is

enforceable against that party in accordance with its terms;

ii. The execution, delivery and performance of this Agreement and consummation of it by the transactions contemplated hereby do not (A) require the consent, waiver, approval, license or authorization of any person that heretofore has not been obtained; (B) conflict with or result in a default under, or create, a lien upon any of the property or assets of that Party pursuant to any agreement or instrument; or (C) violate any judicial or administrative decree, regulation or other restriction of any kind or character to which the Executing Party is a party or by which the Executing Party or any of its assets may be bound; and

iii. There are no actions, suits, or proceedings pending or threatened against, at law or in equity, or before any federal, state, municipal or other governmental department, commission, board, bureau, agency or instrumentality that would, if decided adversely, have a materially adverse effect on that Executing Party or its business.
