Shall the Town of Homer, Parish of Claiborne, State of Louisiana (the "Town"), having been previously authorized at an election held on NOVEMBER 16, 1985 to levy a 1% sales and use tax (the "Tax"), upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and upon the sales of services in the Town, all as defined by law, for an infinite period, (an estimated \$583,000 reasonably expected at this time to be collected for the levy of the Tax for an entire year), be authorized to rededicate the proceeds of the Tax heretofore or hereafter collected as follows: After paying the reasonable and necessary expenses of collecting and administering the tax; (i) 60% to be used for constructing, paving, resurfacing, improving, maintaining, and/or operating expenses for streets in and for the Town, and (ii) 40% to be used for any lawful purpose of the Town.

 - Shall the Town of Homer, Parish of Claiborne, State of Louisiana (the "Town"), having been previously authorized at an election held on NOVEMBER 21, 2015 to levy a 1% sales and use tax (the "Tax"), upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and upon the sales of services in the Town, all as defined by law, for an infinite period, (an estimated \$583,000 reasonably expected at this time to be collected for the levy of the Tax for an entire year), be authorized to rededicate the proceeds of the Tax heretofore or hereafter collected as follows: After paying the reasonable and necessary expenses of collecting and administering the tax; (i) 70% to be used for the purposes of improving, maintaining, and operating public works of the Town, including streets and related drainage, combined sewer and waterworks system, garbage collection and waste disposal facilities, police stations and equipment, public buildings, fire department stations and equipment, public parks and recreational facilities, and purchasing and acquiring the necessary land, equipment and furnishings for the aforementioned public works, title to which improvements shall be in the public, or for any one or more of said purposes, and for further authority to fund a portion of the avails of the Tax into Bonds in the manner provided by law, and (ii) 30% to be used for any lawful purpose of the Town.
- 3. Approve Resolution #25-021-A resolution ordering and calling an election to be held in the Town of Homer, State of Louisiana, to authorize the rededication of a sales and use tax therein, making application to the State Bond Commission, and providing for other matters in connection therewith.
 - Shall the Town of Homer, Parish of Claiborne, State of Louisiana (the "Town"), having been previously authorized at an election held on NOVEMBER 4, 2014 to levy a 1% sales and use tax (the "Tax"), upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and upon the sales of services in the Town, all as defined by law, for an infinite period, (an estimated \$583,000 reasonably expected at this time to be collected for the levy of the Tax for an entire year), be authorized to rededicate the proceeds of the Tax heretofore or hereafter collected as follows: After paying the reasonable and necessary expenses of collecting and administering the tax; (i) to be used primarily for regular residential garbage collection and for further authority to fund a portion of the avails of the Tax into Bonds in the manner provided by law, and (ii) any remaining proceeds to be used for any lawful purpose of the Town.

The Invocation followed by the Pledge of Allegiance was led by Mayor Xanthe Seals.

APPROVAL OF MINUTES FOR REGULAR MEETING DATED AUGUST 11, 2025

Mayor Dr. Xanthe Seals entertained a motion to approve minutes for regular meeting held August 11, 2025. Motion was made by Councilman Jimmy Hand and seconded by Councilwoman Verletha Adams. Motion passes unanimously.

PUBLIC COMMENTS

Ms. Patricia Williams, resident of East Fourth Street, addressed the Mayor and Council in reference to a high utility bill. Mayor Seals stated that the Public Works Department will review the account.

SPECIAL ADMINISTRATOR'S REPORT

Mr. Greer reported that the draft of the 2023Audit Report was complete and should be available soon. The 2024 Audit Report is projected to be completed by December 31, 2025 and the 2025 Audit Report should be finished timely. Mr. Greer updated the Mayor and Council that all State Tax Reports are filed and paid in full and the Town Attorney will be drafting a letter to the Internal Revenue Service (IRS) in reference

to securing a payment plan for the IRS debt. Mr. Koskie stated that financial reports would be available next week; he is currently entering adjusting entries required by the Auditors in the system so that the 2024 Audit could move forward.

If garbage is missed by Republic Services, residents may contact the Business Office at City Hall for assistance. The Town Attorney is reviewing code enforcement regulations.

Councilman Alonzo Mitchell reminded citizens to slow down due to the school year has started back and also for residents to beware of stray animals.

Councilwoman Joyce Ivory recognized Street Superintendent Derrick Burns and Water Superintendent Vivian Moffett for their assistance with a call.

A resolution ordering and calling an election to be held in the Town of Homer, State of Louisiana, to authorize the rededication of a sales and use tax therein, making application to the State Bond Commission, and providing for other matters in connection therewith.

BE IT RESOLVED by the Board of Selectmen of the Town of Homer, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Town of Homer, State of Louisiana (the "Town"), that:

SECTION 1. <u>Election Call.</u> Subject to the approval of the State Bond Commission, and under the authority conferred by the Constitution of the State of Louisiana of 1974, including Article VI, Section 29 hereof, the applicable provisions of the Louisiana Election Code, and other constitutional and statutory authority, an election is hereby called and ordered to be held in the Town on **APRIL 18, 2026**, between the hours of seven o'clock (7:00) a.m. and eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION (SALES TAX REDEDICATION)

SECTION 2. <u>Publication of Notice of Election</u>. A Notice of Special Election shall be published in the official journal of the Town once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days

prior to the date of the election, which Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated herein by reference the same as if it were set forth herein in full.

Notwithstanding the foregoing, prior to the publication of the Notice of Election, the Mayor, or court appointed Fiscal Administrator, is authorized and directed to make any amendments to the forgoing proposition that may be required to comply with any state or federal regulatory agencies.

SECTION 3. <u>Canvass</u>. This Governing Authority shall meet at its regular meeting place, the Council Meeting Room of the Town of Homer Town Hall, 400 East Main Street, Homer, Louisiana, on **APRIL 20, 2026**, at **FIVE O'CLOCK (5:00) P.M.**, and shall then and there in open and public session proceed to examine and canvass the returns and declare the results of the said special election.

SECTION 4. <u>Polling Places</u>. The polling places for the precincts in the Town are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5. <u>Election Commissioners</u>, <u>Voting Machines</u>. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held as provided in Section 3 hereof. All registered voters in the Parish will be entitled to vote at the special election, and voting machines shall be used.

SECTION 6. <u>Authorization of Officers</u>. The Secretary of the Governing Authority is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the Mayor, or court appointed Fiscal Administrator, and/or Secretary of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the election.

SECTION 7. <u>Furnishing Election Call to Election Officials</u>. Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and *Ex-Officio* Parish Custodian of Voting Machines of Claiborne Parish and the Registrar of Voters of Claiborne Parish, as notification of the special election, in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 8. <u>Application to State Bond Commission</u>. Application made to the State Bond Commission for consent and authority to hold the special election as herein provided, and in the event said election carries for further consent and authority to continue to levy and collect the sales and use tax provided for therein. A certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application.

SECTION 9. Employment of Counsel. This Governing Authority finds and determines that a real necessity exists for the employment of special counsel on matters related to the special election, and accordingly, **Pamela N. Breedlove**, is hereby employed as special counsel for the purpose for a term not exceeding one (1) year from the date of this resolution. The fee to be paid said special counsel shall be an amount computed at hourly rate based on the Attorney General's then current Maximum Hourly Fee Schedule, not to exceed \$1,000.00 in the aggregate, together with reimbursement of out-of-pocket expenses, and the Secretary is authorized to pay such invoices as and when presented. The scope of this legal representation does not involve federal claims.

Ordinance No. [25-004]

AN ORDINANCE DESIGNATING THE DOWNTOWN HOMER COURTHOUSE SQUARE AS A NOTHRU-TRUCK ZONE AND DIRECTING HEAVY VEHICLE TRAFFIC TO LA 9 TRUCK AND US 79 TRUCK BYPASS ROUTES

Section 1. Authority

This ordinance is adopted pursuant to Louisiana Revised Statutes Title 32, including but not limited to R.S. 32:41 and R.S. 32:55, granting municipalities authority to regulate traffic on streets within their corporate limits and to designate routes for freight-carrying vehicles.

Section 2. Purpose

The purpose of this ordinance is to promote public safety, pedestrian accessibility, preservation of historic resources, and smooth traffic operations within the downtown Courthouse Square by prohibiting thru-truck traffic and routing such vehicles to the LA 9 Truck/US 79 Truck bypass.

Section 3. Definitions

- Truck: Any motor vehicle or combination of vehicles with a gross vehicle weight rating (GVWR) in excess of 26,000 pounds, designed or used primarily for the transportation of property.
- Thru-Truck: Any truck traveling through the Town without a point of origin or destination on the restricted streets.
- Local Delivery: The operation of a truck for the purpose of delivering or picking up goods, materials, or passengers at locations fronting the restricted streets.

Section 4. Restricted Area

The following streets forming the Courthouse Square are designated as No Thru-Truck Streets:

- East Main Street (from North 2nd Street to North 3rd Street)
- West Main Street (from North 2nd Street to North 3rd Street)
- North Main Street (from East Main Street to West Main Street)
- South Main Street (from East Main Street to West Main Street)

Section 5. Exceptions

This restriction shall not apply to:

- 1. Trucks making local deliveries or pickups to properties abutting the restricted streets.
- 2. Emergency vehicles, public works vehicles, or utility service trucks while on official duty.
- 3. Construction vehicles operating under a valid permit or detour authorization.

Section 6. Alternative Routes

All thru-trucks must use the designated bypass routes:

- LA 9 Truck Route (via US 79 Bypass and LA 2), and
- US 79 Truck Bypass, as signed and maintained by LaDOTD.

Section 7. Signage

The Town shall erect and maintain conspicuous signage at every entrance to the restricted streets, in compliance with the Manual on Uniform Traffic Control Devices (MUTCD) and the Louisiana DOTD Traffic Engineering Manual, clearly notifying operators of the truck prohibition and directing them to the bypass routes.

Section 8. Enforcement

- 1. Any violation of this ordinance shall be a misdemeanor, punishable by fines consistent with R.S. 32:57 and the Town of Homer Code of Ordinances.
- 2. No citation shall be valid unless official traffic control devices giving notice of the restriction were posted at the time of the violation.

Section 9. Effective Date

This ordinance shall take effect immediately upon adoption and upon written approval from the Louisiana Department of Transportation and Development for any statemaintained segments of the restricted streets.

On behalf of Claiborne Unite Foundation, dba Louisiana Legends Festival, I have attached a request for the use of the Homer City Hall complex for the October 2025 festival.

Four previous years, the Louisiana Legends Festival has made the Town of Homer the centerpiece of the annual festival. The festival continues to grow with the total day crowd from 2024 approaching the 6,000-visitor level. The Town of Homer and the Homer Police Department have been great partners in the past and we are looking forward to our continued relationship into the future. The Town's assistance in festival preparation, Town readiness, and the use of and placement of the stage have all helped produce a festival that works to bring positive image of the Town and the Parish.

The 2025 festival planning has been focused on improving our return on assets in both financial and volunteer effort. That focus has led to several key changes. The Legends dinner has been eliminated to allow for a festival day, more public Legend Presentation. We are seeking a more festival friendly space for the very successful Art Contest, we are expecting our annual car show to approach 150 entries, and we anticipate the largest festival yet.
