Debra Sarpy, Homer Housing Authority Director, stated that the Homer Housing Authority have (100) units. Mrs. Sarpy stated the increased rates will affect their budget. The Housing Authority pays the utility bills for each unit.

Councilman Sammy Kirk stated that the Town should be in contact with contractors regarding the maintenance of the water meters.

Councilman Jimmy Hand stated that there should be a customer complaint log in the Business Office and log should document a response to the complaint.

The following ordinance having been introduced at a meeting on November 18, 2024, and a public hearing having been held on December 9, 2024, was offered for final adoption by \_\_\_\_\_ and seconded by \_\_\_\_\_:

**AMENDING BOND ORDINANCE**

An ordinance supplementing and amending a bond ordinance adopted on April 1, 2013, authorizing the issuance of Revenue Refunding Bonds, Series 2013 of the Town of Homer, State of Louisiana, to modify the debt service schedule of such bonds, and providing for other matters in connection therewith.

**WHEREAS**, on April 1, 2013, the Mayor and Board of Selectmen of the Town of Homer, State of Louisiana (the "Governing Authority"), the governing authority of the Town of Homer, State of Louisiana (the "Town"), adopted a Bond Ordinance (the "Original Bond Ordinance") authorizing the issuance of \$2,280,000 of Revenue Refunding Bonds, Series 2013 of the Town (the "Bonds"); and

**WHEREAS**, terms used but not otherwise defined herein shall have the meanings given in the Original Bond Ordinance; and

**WHEREAS**, the Town desires to supplement and amend the Original Bond Ordinance to modify the debt service schedule of the Bonds and provide for other matters in connection therewith; and

**WHEREAS**, pursuant to Section 25 of the Original Bond Ordinance the Town has requested the consent in writing of the Owners of two-thirds (2/3) of the aggregate principal amount of the Bonds outstanding with respect to the modifications to the debt service schedule of the Bonds and related matters; and

**WHEREAS**, pursuant to the authority of the Act, the Governing Authority, by a vote of introduction adopted on November 18, 2024, gave notice of its intention to adopt this amending ordinance, which notice of intention was published on \_\_\_\_\_, 2024, and thereafter this Governing Authority held a public hearing on December 9, 2024 at which no objections were made to the adoption of this amending ordinance; and

**WHEREAS**, this Governing Authority now desires to supplement and amend the Original Bond Ordinance as set forth herein;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Board of Selectmen of the Town of Homer, State of Louisiana, acting as the governing authority of the Town of Homer, State of Louisiana, that:

SECTION 1. *Amendment of Definitions in Original Bond Ordinance.* Section 1 of the Original Bond Ordinance is hereby amended by amending and restating the definitions of “Interest Payment Date” and “Principal Payment Date” in their entirety with the following:

“*Interest Payment Date*” means (a) prior to December 1, 2024, each June 1 and December 1, commencing December 1, 2013 and (b) on and after December 1, 2024, the first calendar day of each month.

“*Principal Payment Date*” means (a) prior to December 1, 2024, each December 1 commencing December 1, 2013, subject to early redemption of the Bonds in accordance with Section 3 hereof and (b) on and after December 1, 2024, the first calendar day of each month, subject to early redemption of the Bonds in accordance with Section 3 hereof.

SECTION 2. *Amendment of Definitions in Original Bond Ordinance.* Section 1 of the Original Bond Ordinance is hereby amended by adding the following definitions in alphabetical order:

“*Original Bond Ordinance*” means the Bonds Ordinance adopted on April 1, 2013 by the Mayor and Board of Selectmen of the Town authorizing the issuance of the Bonds.

“*First Amending Bond Ordinance*” means Amending Bond Ordinance adopted on December 9, 2024, by the Mayor and Board of Selectmen of the Town authorizing the amendment of the debt service schedule for the Bonds.

SECTION 3. *Amendment of Mandatory Redemption in Original Bond Ordinance.* Section 3 of the Original Bond Ordinance is hereby amended by amending and restating subsection (b) thereof in its entirety with the following:

(b) *Mandatory Redemption.* (i) Prior to December 1, 2024, the Bonds are subject to Mandatory Sinking Fund Redemption prior to maturity, including interest accrued to the redemption date on an annual basis commencing December 1, 2013, and continuing on each December 1 thereafter until maturity, in the principal amounts in the years specified in Section 3(b) of the Original Bond Ordinance.

(ii) On and after December 1, 2024, the Bonds are subject to Mandatory Sinking Fund Redemption prior to maturity, including interest accrued to the redemption date on a monthly basis commencing December 1, 2024, in the principal amounts in the months specified as follows:

SECTION 4. *Amendment of Flow of Funds in Original Bond Ordinance.* Section 14 of the Original Bond Ordinance is hereby amended by amending and restating the first paragraph of subsection (b) thereof in its entirety with the following:

The continuation and maintenance of the "Utility System Revenue Bond Sinking Fund" (the "Sinking Fund") sufficient in amount to pay promptly and fully the principal of and the interest on the Bonds by transferring from the Revenue Fund to the regularly designated fiscal agent bank of the Town, monthly in advance on or before the 20th day of each month as follows: (i) Commencing May 20, 2013 through November 20, 2013, one-seventh (1/7) of the interest due on December 1, 2013; (ii) prior to December 1, 2024, commencing December 20, 2013, and the 20th day of each month thereafter, one-sixth (1/6) of interest due on the next Interest Payment Date and then (iii) on and after December 1, 2024, on the 20th day of each month thereafter, all interest due on the next Interest Payment Date; plus (iv) commencing May 20, 2013, through November 20, 2013, one-seventh (1/7) of principal due on December 1, 2013; (v) prior to December 1, 2024, commencing December 20, 2013 and the 20th day of each month thereafter one-twelfth (1/12) of principal due on the next Principal Payment Date, and then (vi) on and after December 1, 2024, on the 20th day of each month thereafter, all principal due on the next Principal Payment Date. All payments in items (i) through (vi) herein shall be made together with such additional proportionate sum (if any) as may be required to pay the full amount of such principal and interest as the same respectively become due.

SECTION 5. *Amendment of Bond Certificate.* The original bond certificate relating to the Bonds shall be amended and restated to reflect the amendments authorized by this Ordinance and delivered to the Owners thereof in exchange for the original bond certificate.

SECTION 6. *Further Actions.* Any one of the Mayor, the Court-Appointed Fiscal Administrator, or any deputy thereof, or person duly appointed in writing to act in the stead of such officer (collectively, the "Responsible Officers"), is hereby authorized and directed for and in the name of and on behalf of the Town to take such actions and to execute such documents and certificates as may be necessary to effectuate the purposes of this Ordinance, including tax documentation, and execution and delivery of any and all memorandums of agreement or understanding, assignments, certificates, requisitions, agreements, notices, consents, instruments of conveyance, warrants and other documents, which they, or any of them, deem necessary or advisable in order to consummate the transactions and requirements as described herein.

SECTION 7. This Ordinance shall be published one time in the official journal of the Town; however, it shall not be necessary to publish any exhibits hereto if the same are available for public inspection and such fact is stated in the publication.

SECTION 8. This Ordinance shall become effective immediately and the amendments to the Original Bond Ordinance contained herein shall be effective as if initially contained in the Original Bond Ordinance. The provisions of the Original Bond Ordinance shall remain in full force and effect except as specifically supplemented and amended hereby.
